- Rapti Academy of Health Sciences has allocated budget towards the cost of Supply, delivery and related services of
 Hospital Pharmacy Medicines and intends to apply part of the funds to cover eligible payments under the Contract for
 Supply, delivery and related services of Hospital Pharmacy Medicines (RAHS/NCB/M&G/03/2080/81). Bidding is
 open to all eligible Bidders from Nepal.
- 2. The Rapti Academy of Health Sciences invites **electronic** bids from eligible bidders for the procurement of **Supply**, **delivery and related services of Hospital Pharmacy Medicines** under National competitive bidding Single Stage Single Envelope procedures.
- 3. Eligible Bidders may obtain further information and inspect the bidding documents by visiting PPMO eGP system www. bolpatra.gov.np/egp.
- 4. The bidder may download the bidding documents on or before 12:00 PM on 2080/05/31 for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

- 5. Pre-bid meeting shall be held at Office of Registrar, RAHS Ghorahi Dang at 11:00 AM on 2080/05/20.
- 6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 PM on 2080/05/31. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2080/05/31 at the office of Registrar. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format in case of e-bid. which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
- 9. For the quality to be tested by Drug and Therapeutic Committee and Quality Committee samples of Hospital Pharmacy Medicines shall be asked by above mentioned committees, failure in submission of samples will result in disqualification and Quality Committee reserve right to qualify or disqualify based on the quality of sample submitted without any regard to price quoted.
