Rapti Academy of Health Sciences has allocated budget towards the cost of **Supply, Delivery and Related Services of Electrical and Plumbing items** and intends to apply part of the funds to cover eligible payments under the Contract for **Supply, Delivery and Related Services of Electrical and Plumbing items**. Bidding is open to all eligible Bidders from Nepal.
2. The Rapti Academy of Health Sciences invites **electronic** bids from eligible bidders for the procurement of **Supply, Delivery and Related Services of Electrical and Plumbing items** under National competitive bidding – Single Stage Single Envelope procedures.

4. The bidder may download the bidding documents on or before **12:00 PM** on **2080/06/29** for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall not be held.
6. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 PM** on **2080/06/29**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM** on **2080/06/29** at the office of Registrar. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format in case of e-bid. which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
9. For the quality to be tested by Quality Committee samples shall be asked by above mentioned committee, failure in submission of samples will result in disqualification and Quality Committee reserve right to qualify or disqualify based on the quality of sample submitted without any regard to price quoted. Bids Will be evaluated by Item-wise Basis.
