1. **Rapti Academy of Health Sciences, Ghorahi** has received a budget from **Government of Nepal** towards the cost of **Procurement of Cardiac Catheterization Laboratory** and intends to apply part of the funds to cover eligible payments under the Contract for **Supply, Delivery and Commissioning of Cardiac Catheterization Machine (Turn-Key Project)** (RAHS/ICB/GOODS/CL/01/2081/82). Bidding is open to all eligible Bidders from all countries.
2. The **Rapti Academy of Health Sciences, Ghorahi** invites **electronic** bids from eligible bidders for the procurement of **Cardiac Catheterization Laboratory** under **International Competitive Bidding – Single Stage Two Envelope**.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the bidding documents by visiting PPMO egp system www.bolpatra.gov.np/egp.
5. Bidder must submit their bid electronically by downloading the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document (ie NPR 10000 or USD 73.59) in the following Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held at **Office of Registrar, Ghorahi** at **11:00 AM NST** on **2025/01/10 (2081/09/26)**.
7. Electronic bids must be submitted to the office of **Registrar, Ghorahi** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM NST** on **2025/01/24 (2081/10/11)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM NST** on **2025/01/24 (2081/10/11)** at the office of **Registrar, Ghorahi**. Bids must be valid for a period of **120 days** from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of **NRs 31,06,001** or **Equivalent to USD**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
